Description

The Commission on Audit, Regional Office No.13, through the General Fund for the year 2019 intends to apply the sum of Twenty-Five Million Pesos (Php 25,000,000.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of PSAO-PDI Building, Phase-1, Brgy. Cuarenta, San Jose, Province of Dinagat Islands. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Commission on Audit, Regional Office No.13 now invites bids for the Construction of PSAO-PDI Building, Phase-1.1 Completion of the Works is required within Two Hundred Seventy (270) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Commission on Audit, Regional Office No. 13, Butuan City and inspect the Bidding Documents at the address given below from 8:00 to 5:00pm.

5. A complete set of Bidding Documents may be acquired by interested bidders on November 22 to December 16, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Fifteen Thousand Pesos (Php15,000.00) only.

1 A brief description of the scope of Works should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

6. The Commission on Audit, Regional Office No. 13 will hold a Pre-Bid Conference² on December 03, 2019 at 2:00pm at the COA Conference Room, Second Floor, COA Regional Office No. 13, South Montilla Blvd., Butuan City, which shall be open to all prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before December 16, 2019 @ 2:00pm. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on December 16, 2019 @ 2:00pm (or immediately after the deadline for submission of proposals) at the COA Conference Room, Second Floor, COA Regional Office No. 13, South Montilla Blvd., Butuan City.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Commission on Audit, Regional Office No. 13 reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
